9. ADDITIONAL TERMS AND CONDITIONS:

The additional terms and conditions that will be applicable to the educational institution to be operated by the Trust are as under:

- 9.1. The management committee of the institution will have one nominated member to be nominated by the joint Director Education.
- 9.2. The institution will have at least 10% seats reserved for the brilliant and extraordinary students of Schedule Caste/Schedule Tribe and they will not be charged more than the prescribed class wise fees of the institutions operated by the Uttar Pradesh Madhyamik Siksha Parishad/Basic Siksha Parishad.
- 9.3. No subsidy or Grant will be demanded by the institution from the State Government. If previously the institution has been registered by the Madhyamik Siksha Parishad then in lieu of getting recognition/affiliation from the Central Board of Secondary Education/Council for the Indian School Certificate Examination all the Subsidy or Grants from the State Government and recognition from the Parishad will stand cancelled from that very date automatically.
